



### New Study – Intimate Partner Homicide: New Insights for Understanding Lethality and Risks

- Sheehan, Murpy, Moynihan, Dudley-Fennessey
   & Staplelton, Violence Against Women, 2015
- Study out of Old Dominion University and the University of New Hampshire
- Interviewed families/friends of 14 homicide victims, reviewed police reports, news releases
- Identified acute risk factors (static/acute):
  - Changes in the perpetrators' behavior (escalating)
  - Perpetrator's perceived loss of control
  - Barriers victims faced when accessing services



#### **Acute Risk Factors**

- Recent stalking
- Change in custody
- Victim's decision to leave
- Recent serious incident of physical abuse that resulted in calling the police
- Non-fatal strangulation assault immediately prior to the homicide
- Perpetrator's cancellation of meeting with divorce attorney
- Confrontation with the victim about perceived affair
- Perpetrator's communication of a threat to a third party

### Key Provisions in PC 13750(e)(f)

- (e) Victims of crime shall not be denied services on the grounds of criminal history. No criminal history search shall be conducted of a victim at a family justice center without the victim's written consent unless the criminal history search is pursuant to a criminal investigation.
- (f) Victims of crime shall not be required to participate in the criminal justice system or cooperate with law enforcement in order to receive counseling, medical care, or other services at a family justice center.

#### Latest Research on the Children of Domestic Violence Homes

- Study was based on the National Youth Survey Family Study, a national sample of 1,683 families, and followed 353 second-generation parents and their thirdgeneration offspring over a 20-year period.
- Children in 75% families ended up becoming victims as adults
- Children in 78.6% of families ended up becoming perpetrators as adults




#### Children's Hope Scale 2015

#### Hope

Hope reflects the individual's capacity to develop pathways and dedicate agency toward desirable goals.



**FIGURE 1** presents the total mean scale scores for the Children's Hope Scale. As seen in the graph, hope scores increased from pre-camp test and post-camp test and again at the follow-up assessment. A repeated measures ANOVA showed that this increase in hope was statistically significant [F (2,172) = 9.22; p< .05;  $\eta$ 2 = .10]. Moreover, the partial eta square reflects a moderate degree of change.uffer to stress and serve as an important indicator of personal well-being (Park & Peterson, 2009).

#### Children's Resiliency Score

Resiliency refers to believing in yourself, believing in others, and believing in your dreams.





FIGURE 8 presents the total mean scale scores for the Children's Resiliency Scale. As seen in the graph, Resiliency Scores increased from pre-camp test to post-camp test and again slightly at the follow-up assessment. Repeated measures ANOVA showed that this increase in Resiliency was statistically significant [F (2,162) = 14.29; p< .05; η2 = .15]. Moreover, the partial eta square reflects a moderate degree of change.




- The vision is bigger with TJSL




- Collaborative, coordinated public health approaches with CA/DV/SA together Merged CACs and FJCs
