Domestic violence is the willful intimidation, physical assault, battery, sexual assault, and/or other abusive behavior perpetrated by an intimate partner against another.

Georgetown County ranks as the sixth worst in reported cases of CDV with 515 in 2008. It is estimated by experts in this field that this represents one fourth of all annual cases.

Criminal Domestic Violence (CDV) is not influenced by race, color, creed, or social or economic status. It occurs at every strata of society and throughout all familial relationships.

What is a Family Justice Center (FJC)?

The FJC is a collaborative community response to criminal domestic violence (CDV). The model is based on the Family Justice Center (www.familyjusticecenter.org) which opened in San Diego 2002. This FJC model has been identified as a best practice in the field of CDV intervention and prevention services.

The documented and published outcomes in the Family Justice Center model have included:

- ✓ reduced homicides
- ✓ increased community support services
- ✓ increased victim safety
- ✓ increased autonomy and empowerment for victims
- ✓ reduced fear and anxiety for victims and their children
- ✓ reduced recantation and minimization by victims
- ✓ increased prosecution of offenders
